# **Availability**

## **Payment**

All prices quoted on the Website are in South African Rand (ZAR) and include Value-Added Tax. Prices quoted are per bottle or per case, as indicated. Payment is accepted via credit card (Visa, Master Card, Diners) or by direct electronic transfers.

## **Credit Card Security and Privacy**

## **Delivery**
